This is a summary of the annual report for the DIVISION 1181 A.T.U. - NEW YORK WELFARE FUND, (Employer Identification No. 23-7255573, Plan No. 503) for the period January 1, 2021 to December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INSURANCE INFORMATION

The plan has contracts with Lincoln Life and Annuity Company of NY and Shelter Point Life Insurance Company to pay Group Life, Accidental Death and Dismemberment and Group Disability claims. The total premiums paid for the plan year beginning January 1, 2021 and ending December 31, 2021 were \$3,473,610.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$61,595,557 as of December 31, 2021 compared to \$43,801,172 as of January 1, 2021. During the plan year the plan experienced an increase in its net assets of \$17,794,385. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$116,778,372. This income included employer contributions of \$104,946,482, employee contributions of \$11,148,228, earnings from investments of \$505,624 and other income of \$178,038. Plan expenses were \$98,983,987. These expenses included \$5,882,083 in administrative expenses and \$93,101,904 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
