## **Pension and Welfare**

A special message from Robert D'Ulisse Funds Administrator:

In order to eliminate some confusion that we have had in the past, I would like to emphasize if you are on Disability or Workers' Compensation for the maximum amount of time, allowed in your contract, and are not able to return to work, please contact the Fund Office for them to determine if you are eligible to retire or vest your Pension benefit for a future date. This could prevent any loss in your monthly Pension benefit if you are eligible due to any late filing. You can request the Pension Department to do a work up and inform you if there are any Pension contribution shortages that you may owe while you were out of work for any reason.

Also, if you are not able to return to work and are not eligible for a Pension, you still need to contact the Pension Department for them to do a work up for you to get a refund of the contributions and interest that you would be entitled to, if you do not have vesting rights.

Please be aware that if you were on Disability or Workers' Compensation and did return to work, your employer will be doubling up on the Pension deduction for time that you were out on Disability or Workers' Compensation for which there were no contributions made on your behalf. This will prevent issues that may come up at retirement because of failure to pay your portion for the time you were out.

#### **Welfare Fund:**

Welfare monthly reserve for October is 11.69 months and for November is 12.19 months.

As you are aware, the Union has negotiated and their recent Memorandum of Agreement (MOA) with the Contractors in which they were successful in eliminating the copays for Radiology and Lab work. This is to be effective as of January 1, 2024. Empire Blue Cross Blue Shield is in the process of updating their computer system to accommodate this change in your Welfare benefits. Unfortunately, they will not have it updated by January 1. Therefore, you may be charged for these copays until their system has been fully updated. Please be assured that Blue Cross Blue Shield has committed to us that any claims that you may have paid for these

copays starting January 1, 2024, will be recycled and generate a reimbursement check to you. We have been assured that you do not have to present a receipt that you paid these copays. If you have recently moved and have not updated the Fund Office, kindly do so immediately because Empire Blue Cross Blue Shield will generate the check and mail it to the address that the Fund has on file. We are sorry for any inconvenience that this may cause. We are told that Blue Cross is working diligently to update their system as soon as possible.

Effective as of April 1, 2024, Empire Blue Cross Blue Shield will be changing their name to Anthem Blue Cross Blue Shield. Empire Blue Cross Blue Shield has been operating under Anthem since 2006. There will be no impact or changes made to their pricing, networks, coverage, or level of support that you have been receiving in the past. You should receive your card sometime in March. Once you do, kindly disregard your old card for April 1<sup>st</sup> going forward. It is imperative that the Fund Office has your current address since Blue Cross will be mailing out your card based on the address we have on file. If you need to change your address, contact the Fund Office as soon as possible.

#### **Pension Fund:**

The Preliminary Pension Fund's Assets for October was \$638,274,408, and the Preliminary Pension Fund's Assets for November is \$675,082,017.

- Please note, if you have recently moved and have not notified the Fund Office, please call and we will gladly send you a form to complete so we can update our records, and for you to be able to receive all future mailings timely.
- As a reminder, we are updating our computer system and we would like to have your email address so we can send you correspondence on a timelier basis. We will send you correspondence asking for your email address and if you would want all your

- correspondence sent by email, if possible. If we do not hear from you, we will assume that you do not want to receive documents by email.
- We encourage you to go to the website (<a href="https://atu1181.org">https://atu1181.org</a>) from time to time to see if any new documents or information have been added to keep you informed.
- In order to eliminate some confusion that we have had in the past, I would like to remind you that if you are suspended from work or laid off through furlough, your Welfare benefits will cease at the end of the month that you were suspended or laid off. You have the right to take COBRA and will receive a COBRA Notice in the mail from Conexis. If you do not take COBRA, you will be responsible for any medical claims for that time period that you did not have medical coverage.
- If you are on Disability or Workers' Compensation, you are covered for Welfare benefits for the time you are eligible per your contract with your Company. After such time is exhausted, you will no longer have Health and Welfare coverage unless you opted for COBRA, or if you are eligible to retire with at least ten years of service.
  - ❖ If you are on Disability or Workers' Compensation and return to work, your Employer will be doubling up on the Employee welfare (Cafeteria) deduction for the period that you were out of work.
- If there are any major changes in your life, you may want to confirm who you have designated as your beneficiary and contingent beneficiary for your life insurance under the Welfare Fund.
