Subject: Election for ATU 61st Convention Delegates

We are requesting nominations for the 61<sup>st</sup> ATU International Convention of Delegates to be held from August 18<sup>th</sup> - 22<sup>nd</sup>, 2025. Anyone interested in running for convention delegate please PRINT your name on the attached notice by 12:00 pm on Wednesday, June 18<sup>th</sup>, 2025.

Pursuant to our International Constitution and General By-Laws, election for Convention Delegates must be held six (6) weeks prior to the Convention. In order to run, you must be a member in continuous good standing of the Local Union for two (2) years.

The Executive Board by virtue of their elected positions are convention delegates; our Local is entitled to a total of 33 convention delegates. There will be an election held for the other 20 positions, plus 4 alternates. The Executive Board shall determine how may delegates may attend the convention.

Nominations do not need a second and those wishing to nominate in person may come to the union office by 12:00 pm on Wednesday June 18<sup>th</sup>, 2025. There will be a posting over the next couple of days with information just described to you.

Election day will be held on July 7, 2025 and will be conducted by the American Arbitration Association (AAA). After nominations are received, Financial Secretary-Treasurer Jean Claude Calixte will verify eligibility and contact all the nominees received by this Local to verify their intent to run. Those names will then be forwarded to AAA to be placed on a ballot.

The Constitution provides where two (2) or more positions as delegates to a Convention are to be filled, then all nominated members' names shall appear on the same ballot in alphabetic order, and the members receiving the most votes in order shall be elected delegates to that Convention (i.e., eleven delegates to be elected, top eleven vote getters are elected). This procedure is in total compliance with the Constitution of the Amalgamated Transit Union.

## NOTE:

Ballots will be mailed on June 20, 2025 to the last known address on file with this Local Union. Ballots must be received by the American Arbitration Association by mail no later than 9:00am on July 7<sup>th</sup>, 2025.

Again, election day will be held on July 7th, 2025 and ballots will be counted on that day by the American Arbitration Association (AAA).
