

## Department of Elections Certification of Results

## Local 1181-1061, Amalgamated Transit Union, AFL-CIO

Pursuant to a letter of agreement with Local 1181-1061, Amalgamated Transit Union, AFL-CIO, hereinafter referred to as "Local 1181", the American Arbitration Association, hereinafter referred to as the "Administrator," agreed to conduct an Election of Officers.

Local 1181 provided the Administrator with all lists of persons who were eligible to vote. Fourteen Thousand Forty-Eight (14,048) ballots were mailed to eligible voters on Friday, May 16, 2025. Additional ballots were later mailed to eligible members not included in the original mailing list: Forty-Five (45) ballots were mailed by Thursday, May 22, 2025 and Five (5) more ballots were mailed by Wednesday, May 28, 2025.

During the course of the election, Sixty-Two (62) ballots returned due to a bad address were remailed to the updated address provided by USPS on the undeliverable mail piece. Forty-Nine (49) ballots were re-mailed to an updated address provided by Local 1181.

One Hundred Eighty-Eight (188) duplicate ballot requests were fulfilled as a result of calls to the Administrator's Duplicate Request line.

In order to be counted, ballots were to be received no later than 9:00 AM on Friday, June 6, 2025. The Administrator received Three Thousand Five Hundred Twenty-Six (3,526) envelopes before the deadline.

The tabulation of results occurred on Friday, June 6, 2025, at 10:00 AM at the Administrator's office located at 120 Broadway, Concourse Level, New York, NY 10271 in the presence of observers and the election committee. Three Thousand Five Hundred Two (3,502) envelopes

were opened. Twenty-Four (24) envelopes were set aside before the count for the following reasons:

- 13 Voters did not appear on the final eligibility list
- 9 Envelopes lacked identification to verify the voter's eligibility
- 2 More than one envelope was received from the same voters (latest postmark was counted and the other envelope was voided)

The secrecy of the results was maintained at all times. The results are certified to be as follows:
